Daily talk, not a consultant on call.

- Daily 2–4 min toolbox-talk post
- Monthly digest: OSHA citing (national + AZ / construction / GI)
- Template locker (talks, punch lists, sign-in)
- No questions line

02 COMPLIANCE DESK

\$149 /mo

Owners who need “is this a thing?”

- All of Shop Floor
- 2 written questions / mo (2 business-day reply)
- 1 existing document review / quarter (8 pages)
- One 20-min call / quarter

03 INSPECTION READY

\$499 /mo

POPULAR

Same-day line if an inspector arrives.

- Daily topics + 4 custom topics / mo
- Digest + templates + binder checklist / qtr
- 4 written questions / mo · 45-min planning call / mo
- Inspection response: 2-hr BH reply (4-hr AH), 3 remote hrs/event, 1 event/mo — coaching only, not on the 1B

04 FRACTIONAL LEAD

\$1,500 /mo

Monthly walk + weekly EHS rhythm.

- Custom daily topics · digest + open-item tracker
- Weekly 20-min standup + 6 remote hrs / mo
- Monthly GC site walk (3 hrs, one site) + written CAPA
- Auth-rep support: 8 hrs/event, 2 events/mo; informal conference coaching in those hours

NOT INCLUDED ON ANY PLAN

- Extra on-site days beyond the monthly walk
- Additional sites or full mock-OSHA audits
- New written programs from scratch
- IH sampling; fatality / catastrophe response
- Formal citation contest / Review Commission (attorney)
- Acting as site safety officer of record
- Extra inspection / informal hrs \$225–\$275
- Extra local half day \$750–\$1,000 · full day \$1,200–\$1,800 + mileage
